## What will you learn?

The Inter-Agency Toolkit: Preventing and Responding to Child Labour in Humanitarian Action for Middle East and Northern Africa and accompanying learning package were released by the Child Labour Task Force (Alliance for Child Protection in Humanitarian Action) in 2022. The Child Labour Task Force of the Alliance in collaboration with the Global CP AoR (Arabic Help Desk) would like to offer you a free, online learning opportunity to further explore the guidance and tools to strengthen overall understanding of preventing and responding to child labour in humanitarian action. The course will provide an introduction to child labour in humanitarian action, and will allow you to reflect on how the IA toolkit is relevant to your context.

#### What will you achieve?

By the end of the online course you will be able to:

- Define child labour, worst forms of child labour and its impact in humanitarian crisis
- Explain strategies to prevent and respond to CL and give examples of how these may be applicable in own context
- Describe actions to integrate child labour in humanitarian programming
